SECTION 5. WELL REGISTRATION AND PERMITTING

RULE 5.1 REGISTRATION OF EXISTING WELLS

Within one hundred and twenty (120) days after the effective date of these Rules, any well existing in the District on or before the effective date of these Rules that is capable of producing more than 25,000 gallons of groundwater per day must be registered with the District on a form prescribed by the District. Any other well in the District existing on or before the date of these Rules may be registered at any time with the District on a form prescribed by the District. A registration number will be issued for each well registered under this Rule 5.1 after the location of such well has been determined by the landowner and District personnel. All wells so registered shall be equipped and maintained so as to conform to the standards of the Texas Water Well Drillers and Pump Installers Rules.

Information for completing Well Registration Application

1. Use your current mailing address
2. Well Size: The Casing Size is the size of the large pipe extending into the well. Pump Size should be in horsepower and is usually listed on the electric box that powers the pump or on the pump if it is above ground. Pump Type: If the pump is above ground it is usually a Jett Pump. If it is in the well it will be a submersible. Of course there is the chance it is a windmill. Maximum yield: This is the amount that the well shows to be capable of producing and is usually listed in GPM. Depth: The depth that the well was drilled to. Water Level: The level that the water rises to inside the well. Surface Completion: If there is a large steel or large PVC Pipe then it will be Sleeve. If there is a concrete slab around the well then it will be slab.
3. Use: Check the primary use and then check all that apply
4. Driller Name: Complete if known. Date drilled: Complete if known.
5. Location: Check either Edwards or Real County. Then include a brief set of directions: Ex. 1 mile on CR 450 off HW 377 or 4 miles north of Rocksprings on HW 41...

Complete information on Section Block survey if known.

List Subdivision if well is in a subdivision

List GPS Coordinates and Grid if known

Number of Acres: list the number of acres in the property that the well sits on.

Distance to Property Line: Approximately how many feet from the well to the nearest property line.
